How to Register

1. Fill out the registration form.
2. Three important Oregon State Park changes for 2010: (a) prices went up \$4 per day; (b) campsites now must be paid in full at time of registration (so you no longer pay when you arrive at the park); and (c) we are required to pay for the full week for each site.
3. The fees below include \$147 per week for a tent site or \$182 per week for a trailer site (that goes to Oregon State Parks), plus the Family Camp program fee of \$78 per family.
4. All checks should be made payable to "Presbytery of the Cascades".
5. **Early bird registration fees before June 1st** are:
 \$225.00 for a tent site
 \$260.00 for a trailer site
After June 1st and before July 10th registration fees are:
 \$245.00 for a tent site
 \$280.00 for a trailer site
NO REGISTRATION AFTER JULY 10th.
6. We reserved only 55 sites this year, so Family Camp could fill up. **Sites are available first-come, first-served.**
